CLIENT CONTRACT AGREEMENT

Agreement made this _____ of _____, _____, between _____ and J Lee Studio.

Please read and initial next to each of the policies below:

_____ Each student is designated a specific day and time weekly for lessons, which is reserved only for the student. Students are expected to attend all scheduled lessons, unless otherwise arranged in advance with the studio.

_____ Tuition rates for lessons per month are as follows:

30 minutes - \$140/month

45 minutes - \$180/month

60 minutes - \$240/month

*Note: Monthly tuition rate will stay constant regardless of 4-week months or 5-week months

_____ Tuition for lessons are due first day of the month. Any tuition received after the first week of the month will be considered late and will incur a 10% late fee for each 30-day period that the payment is not made in full.

_____ Cash payment of tuition only.

_____ Extra materials such as books and participation in master classes, recitals and other activities will be charged separately from the tuition for private lessons. Students will be charged the replacement cost for any borrowed materials which have been lost.

_____ If lessons are terminated by the student before the end of the month, no refund will be given. If the studio terminates lessons, tuition will be refunded for the week missed.

_____ The parent(s) and student(s) hereby waives, releases, discharges, and covenants not to sue the studio, its owners, employees, agents or representatives from any and all liability, claims, demands, losses, or damages arising out of, or related to, the student's participation in studio on-site or off-site lessons, events, or activities ("Studio Programs"), whether based in contract or tort. The parent(s) and

student(s) agree to indemnify, defend, and hold harmless the releases from any and all claims, demands, losses, attorney's fees, costs, liabilities, or damages against studio arising out of the student's participation in any Studio Programs.

_____ The parent(s) and/or student(s) hereby consents to and authorizes the studio to capture and use video-audio recordings and photographic images of the student and the student's musical performances and quoted statements in print, electronic, or online media for educational and studio promotional purposes only, without any compensation to the parent(s) or student(s). The parent(s) and/or student(s) agrees to waive and release any and all claims parent(s) may have against the studio relating the use of these recordings, images, or statements. This consent is binding upon all heirs and future legal representatives. The studio will not personally identify a minor child by full name in connection with a video recording or photographic image of the child, unless the studio receives separate written signed consent from the parent(s).

_____ In the event of any dispute, claim, or disagreement arising from this Studio Policy & Agreement, the parties shall use their best efforts to settle the dispute. The parties shall consult and negotiate with each other in good faith, and recognizing their mutual interests, attempt to reach such solution within a period of sixty (60) days, then upon notice by either party or the other, all disputes shall be finally settled by arbitration administered by the American Arbitration Association in accordance with the provisions of its Commercial Arbitration Rules, and judgment on the award rendered by the arbitrator(s) may be entered into any court having jurisdiction thereof.

_____ If any term or provision of this Studio Policy and Agreement is illegal or invalid for any reason, such provision is severable from the rest and shall not affect the legality or validity of the remainder of this Studio Policy and Agreement.

Makeup Lesson Policy

_____ Make up lessons are only allowed if there is at least a 24-hour notice in advance prior to the lesson date, unless in case of an emergency.

_____ Less than a 24-hour notice forfeits any makeup lessons and tuition will be rendered.

_____ If a scheduled makeup lesson is missed, there will be no other make up lessons offered to re-schedule a scheduled makeup lesson and will be considered fulfilled. There will be no refund.

_____ A refund will be administered for the instructor's absences or illness. Alternatively, the student may choose to receive a makeup lesson instead of a refund for the missed lesson.
